**THIS MOTION**, made by Class Counsel for an Order approving the payment of legal fees and disbursements of Goldblatt Partners LLP (“**Class Counsel**”) and an honorarium to the representative plaintiff, was heard this day by video conference.

**WHEREAS** the Court approved the Settlement Agreement between the parties pursuant to which the defendant agreed to pay \$7,000,000.

**ON READING** the materials filed and on hearing the submissions of Class Counsel;



1. **THIS COURT ORDERS** that, in addition to the definitions used elsewhere in this Order, for the purposes of this Order, the definitions set out in the Settlement Agreement apply to and are incorporated into this Order.
2. **THIS COURT ORDERS** that the retainer agreement entered into by the plaintiff and Class Counsel dated February 19, 2019 (the “**Retainer Agreement**”) is approved.
3. **THIS COURT ORDERS** that the fees plus applicable taxes of Class Counsel are approved.
4. **THIS COURT ORDERS** that the disbursements plus interest and applicable taxes of Class Counsel are approved.
5. **THIS COURT ORDERS** that legal fees of \$1,750.00 plus HST of \$227,500 and disbursements of \$34,589.07 and taxes thereon, are awarded to Class Counsel.
6. **THIS COURT ORDERS** that an honorarium of \$10,000 (all inclusive) to the representative plaintiff Stephen Aps is approved.
